GENERAL PRICE LIST

These prices are effective as of JUNE 1, 2023 and are subject to change without notice.

The Federal Trade Commission (FTC) and the New York State Department of Health both require that certain disclosures be made by funeral providers on the General Price List. Although these disclosures are similar, they are not exactly the same. This General Price List contains both sets of the required disclosures. The disclosures required by the FTC, when different from those required by the Department of Health, are preceded by the letters "FTC".

The goods and services shown below are those we can provide our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our services. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral services and merchandise you selected.

This list may not include prices for certain items that you select, such as cemetery charges or crematory services, flowers and newspaper notices. The estimated or final prices for those items will be shown on the itemized statement describing the funeral services and merchandise you selected. We charge you for our services in buying certain items.

(FTC) "The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead services. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected."

Transfer of remains to the funeral establishment

FTC

(FTC) "Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as a direct cremation or immediate burial."

Preparation of remains, unless selected, is not required for direct cremation or direct burial

Arrangements/ Basic Services of Funeral Director & Staff

(Federal Trade Commission Disclosure FTC) This fee is for our basic services and overhead will be added to the total of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, direct/immediate burials, forwarding or receiving remains).

(New York State Disclosure NYSDOH) The charge for our services will be added to the total cost of the funeral arrangements you select. However this charge will not be added to the cost for direct cremation, direct burial, forwarding of remains or receiving of remains because the prices for those services include this charge.

Alternative Services

The following charges for direct burial and direct cremation do not include additional items or services, merchandise, facility use, and livery that the customer may wish to select.

Direct Cremation: (at the convenience of the funeral home)

Prices range from \$ 3,975.00

which includes the local transfer of remains to the funeral home, staff, securing necessary authorizations, basic local transportation to the crematory, an alternative container for cremation, and the return of the cremains to the funeral home.

to \$ 3,780.00

which includes the services as described but with the cremation container supplied by the customer.

If you want to arrange the direct cremation, you may use an unfinished wooden box or an alternative container. Alternative containers can be made of heavy cardboard, pressed wood or composition materials (with or without an outside covering), or if permitted by crematory, may be pouches of canvas or other materials.

The direct cremation prices does not include the crematory charge.

(FTC)

If you want to arrange the direct cremation, you may use an unfinished wooden box or an alternative container. Alternative containers can be made of heavy cardboard, pressed wood or composition materials (with or without an outside covering), or if permitted by crematory, may be pouches of canvas or other materials.

Direct Burial: (at the convenience of the funeral home)

Prices range from \$ 3,975.00

which includes the local transfer of remains to the funeral home, staff, securing necessary authorizations, basic local transportation to the cemetery, an alternative container for burial.

which includes the services as described but with the alternative container supplied by the customer.

Prices range from \$ 3,780.00

The direct burial prices does not include the cemetery charge.

Limited Services

Forwarding remains to another funeral home \$ 3,995.00

This charge includes the local transfer of the remains to the funeral establishment services of funeral directors and staff, embalming, securing necessary authorizations, minimum shipping container and local transportation to point of shipment. The charge does not include shipping charges or additional items of services, merchandise, facility use, and livery that the customer may wish to select. Local point of shipment is up to or within 25 miles.

Receiving remains from another funeral home \$ 2,995.00

This charge includes the basic transportation of the remains to the funeral establishment or place of local disposition, services of funeral directors and staff, securing necessary authorizations. The charges do not include additional items of services, merchandise, facility use and livery that the customer may wish to select. Local place of disposition is up to, or within 25 miles.

Cash advances

(New York State Disclosure NYSDOH) Services and Merchandise provided as cash advance items will be billed at the same rate paid by the funeral home)

These are charges that may be needed to be paid out to third parties who are involved with the funeral services. The funeral home will disperse cash advances on the family's behalf. Every funeral is different, therefore, we are providing a list of possible cash advances that may be paid out on behalf of the purchaser. The list may include some of the following items.
